INTRODUCTION

No' 13 Queen Elizabeth Drive is situated within the picturesque market town of Castle Douglas occupying an elevated site and from the first floor, provides stunning views across the rooftops towards the surrounding countryside. The property is conveniently located within a short walking distance to all town centre amenities, the popular Fullarton Theatre and the pretty Carlingwark Loch.

No' 13 Queen Elizabeth Drive benefits from neutral décor throughout and has recently been fitted with new carpets. The property offers accommodation over two floors benefitting from a utility room, integral single garage and private driveway. Enclosed garden grounds to the rear are mainly laid to lawns with a timber garden shed and a dedicated paved patio, making this the perfect area for family and social entertaining. The garden to the front of the property is laid to lawns and bound by a granite wall.

As mentioned earlier, local services are conveniently located only a short walk to the thriving High Street of Castle Douglas (The Food Town), which offers all essential services and is renowned for its niche retailing with a wide range of traditional shops, delicatessens, craft beer and wine outlets, butchers, bakers' grocers, craft outlets, etc. Both primary and secondary schools are also available within the town along with a modern health centre and a wide range of professional services, as well as two national supermarkets.

Communications to the area are good with the property lying in close proximity to the main A75 Euro Route, which provides quick access from the south via the M6 & M74. Cairnryan, the ferry link with Northern Ireland is a little over an hour's drive via the A75 and the international airports of Glasgow & Edinburgh within an easy drive of the property. There are mainline railway stations at both Dumfries and Lockerbie.

This area of Southwest Scotland enjoys one of the most varied and picturesque landscapes within Scotland, ranging from the moorland of the Southern Upland Hills to the bays and sandy beaches of the distinctive coastline. This is a rural county where agriculture and tourism thrive to form the backbone of the local economy. The area has been relatively unscathed by modern industry.

The region is well-known for the quality and variety of both field sports and leisure activities with the outdoor and sporting enthusiast extremely well-catered for as there exist the ability to take both shooting and fishing locally. Given the diverse landscape along with the proximity to the coast and local lochs, the area offers unique walks, sailing, cycling and for the golfer there is an abundance of good local courses with the region boasting no fewer than twenty-nine courses, the closest being within Castle Douglas.

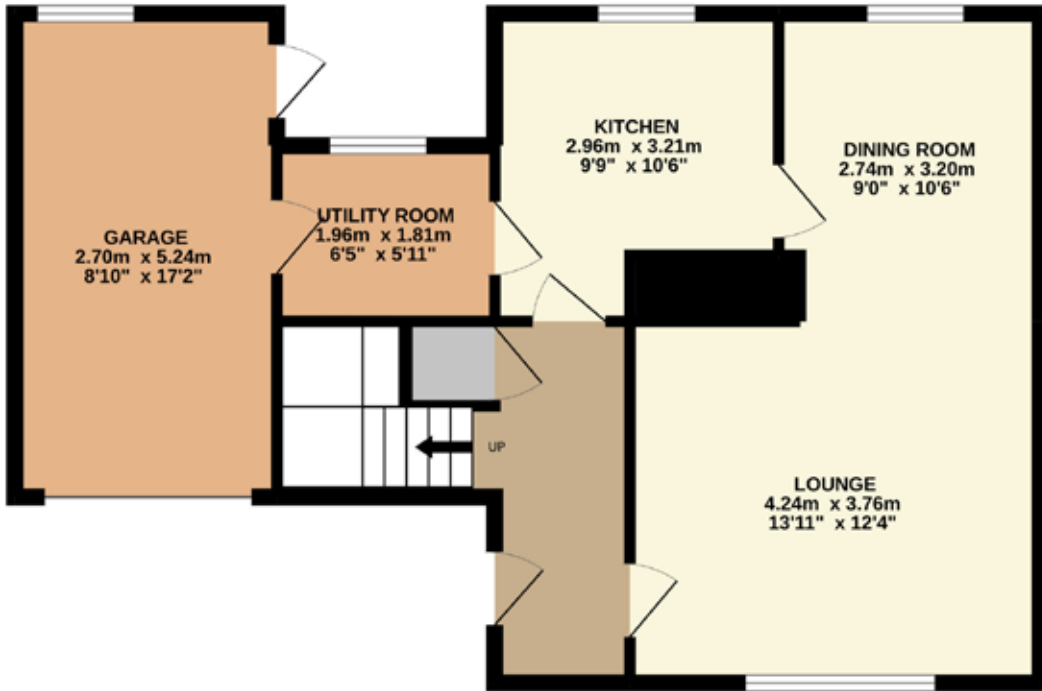

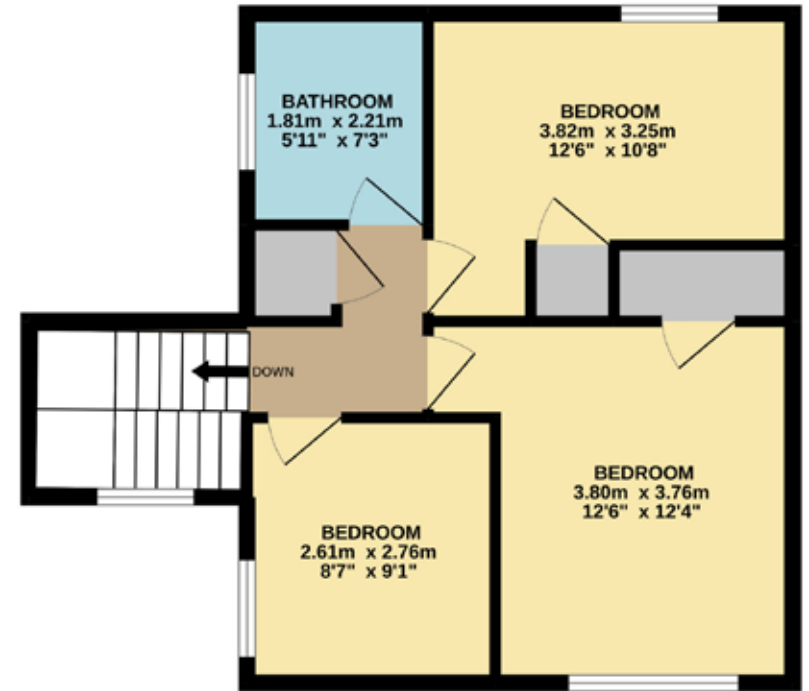


Floor Plan

PARTICULARS OF SALE

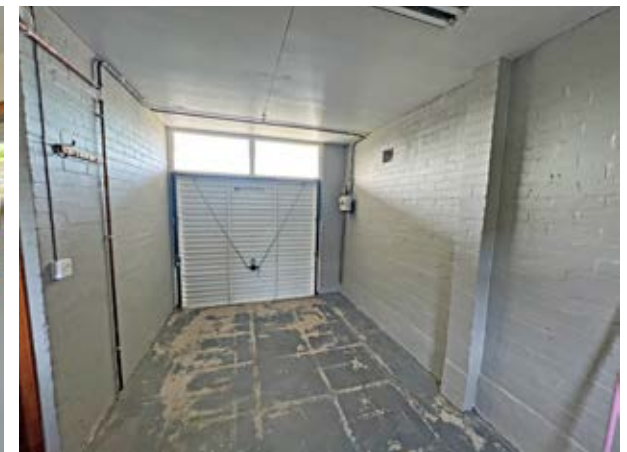
No' 13 Queen Elizabeth Drive offers bright, well-presented three-bedroom family accommodation over two floors, briefly comprising:

GROUND FLOOR

- **Central Hallway**
With a walk-in storage cupboard and stairs off to the first floor.
- **Living Room**
With a picture window to the front and window to the rear overlooking the garden grounds. The living room has ample room for family dining.



- **Kitchen**
With a modern range of floor and wall units, window to the rear.
- **Utility Room**
With a Belfast sink, plumbed for white goods, door off to integral garage, window to the rear.



- **Integral Garage**
With up and over door and personnel door to the rear, leading to the garden grounds.

FIRST FLOOR

- **Mid Landing**
With a window to the front.
- **Upper Landing**
With a built-in storage cupboard.



- **Single Bedroom 1**
With a window to the side affording views over the rooftops of Castle Douglas.
- **Double Bedroom 2**
With built-in cupboards and a picture window to the front providing views across the town towards the hills beyond.
- **Double Bedroom 3**
With built-in cupboards and a window to the rear.
- **Family Bathroom**
With a modern range of sanitary ware and bath with shower over.

As mentioned earlier, there are enclosed garden grounds to the rear of the property which have an area of lawn, a paved patio area and a timber garden shed. To the front, the garden is laid to lawn.
